



**Directions to NASW-NJ**

**By train:** Take New Jersey Transit to the Edison stop - it is one stop north of New Brunswick and one stop south of Metuchen. Our building is diagonally across Plainfield Avenue from the train station. There is a pedestrian walkway crossing ABOVE Plainfield Avenue from the station to our side of the street.

**By car: Parking is free but be sure to sign your car in at the Security Desk in the lobby, especially during daytime hours.** (Your car might be towed if you don't sign it in.)

NOTE: All roads in the area heavily congested during rush hours. ALLOW EXTRA TIME.

**From the North or Northeast** (Bergen, Passaic, Essex, Union, Hudson, and north):

1. NJ TURNPIKE, Exit 10: Take the New Jersey Turnpike to Exit 10. Take 440 West/287 North to Route 27 South (exit sign says New Brunswick, 27 South), which is about 2 1/2 miles. After reaching Route 27 South, proceed 1-7/10 miles to intersection with Plainfield Avenue and turn right onto Plainfield Avenue. Proceed about a mile to the Metroplex Corporate Center, **IMMEDIATELY** after you go under the railroad overpass on the right. (alternate exit is to go to Exit 9 of the Turnpike, see below)
2. PARKWAY: Take Parkway South to Exit 130, exiting onto Route 1 South. Travel approx. 5 miles and follow directions in #3 below.
3. ROUTE 1 SOUTH: Take Rt. 1 to Plainfield Avenue exit. Turn right at stop sign. Proceed about a mile to the Metroplex Corporate Center, **IMMEDIATELY** after you go under the railroad overpass. (alternate exit is to go to Exit 9 of the Turnpike, see below)

**From the South**

4. NJ TURNPIKE, Exit 9: Take the New Jersey Turnpike to Exit 9. Exit to Route 18 North. See directions below
5. PARKWAY: Take the Parkway north to Exit 127, for 440 West/287 North. It is the exit just as you come off the bridge, so be sure to be in one of the 2 right hand lanes as you approach the bridge from the toll plaza. Bear left at the exit for 440 West/287 North. Stay on 287 North until you reach the exit for Route 27 South. Proceed 1-7/10 miles on Route 27 until you reach the intersection with Plainfield Avenue. Proceed as in (1) above.
6. ROUTE 18 NORTH: Take 18 North to Route 1 North. Take Route 1 North for just over 1 mile to the first traffic light, which is Plainfield Avenue. Bear right **IMMEDIATELY** after the traffic light onto the jughandle (it says Plainfield Avenue North - Piscataway, Dunellen), and follow Plainfield Avenue about a mile to the Metroplex Corporate Center, **IMMEDIATELY on your right** after you go under the railroad overpass.
7. ROUTE 1 NORTH: Take the Plainfield Avenue jughandle, (it says Plainfield Avenue North - Piscataway, Dunellen). Proceed about a mile to the Metroplex Corporate Center, **IMMEDIATELY** after you go under the railroad overpass on your right. (alternate exit is to go to Exit 9 of the Turnpike, see below)

**From the West or Northwest**

8. I-287: Take 287 South to Exit 5, 529 South-Edison (which is Stelton Road and becomes Plainfield Avenue), bear right at the end of the exit. (If you are on 287 North, turn left at the end of the exit.) Take 529 South for approximately 3 miles; Metroplex Corporate Center is on your left, just **BEFORE** you would go under the railroad overpass.
